MUNICIPAL ORDINANCE NO. 126-22 Series of 2022

“AN ORDINANCE RE-ALIGNING & RE-PROGRAMMING THE 2022 20% LOCAL DEVELOPMENT FUND IN THE AMOUNT OF THREE MILLION EIGHT HUNDRED THOUSAND PESOS (P3,800,000.00) INTO OTHER INFRASTRUCTURE PROJECTS EQUALLY BENEFICIAL TO THE PEOPLE OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the Municipal Development Council (MDC) of San Benito through MDC Resolution No. 003-2022 recommends to this august body for re-alignment of the 20% Local Development Fund of 2022 programs into other equally beneficial infrastructure projects for the benefit of the people of San Benito, which was duly endorsed by the Office of the Municipal Mayor through its letter requesting this body to enact a re-alignment ordinance for this purpose;

WHEREAS, presented for consideration is the 2022 20% Local Development Fund in the amount of Three Million Eight Hundred Thousand Pesos (P3,800,000.00) to be re-aligned and re-programmed to other equally beneficial infrastructure development projects of the municipality;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member William A. Polican duly seconded by Sangguniang Bayan Member Puyat P. Sumando,

BE IT ORDAINED, by the 10th Sangguniang Bayan of San Benito, Siargao Island, Surigao del Norte in session assembled, that:

Section 1. Purpose. This Ordinance is intended to re-align and re-program the 2022 20% Local Development Fund in the amount of Three Million Eight Hundred Thousand Pesos (P3,800,000.00) into other equally beneficial infrastructure projects for the benefit of the people of San Benito, Siargao Island, Surigao del Norte.

Section 2. Sources of Funds for Re-alignment and Re-program. The following are the 20% LDF programs and projects for 2022 certified by the Municipal Development Council through MDC Resolution No. 003-2022 as sources for re-alignment, to wit:

Purchase of Children Play Ground & Facilities	- P 1, 200,000.00
Slaughter House Construction	- P 2, 200, 000.00
Access Road going to Slaughter House	- P 400, 000.00
Total Amount for Re-alignment	- P 3, 800, 000.00

Section 3. Proposed Projects for Re-alignment and Re-program. The following are the proposed programs for re-alignment based on the total aggregate amount of the 20% LDF, to wit:

- **Concreting of Municipal Road** - P 2, 000, 000.00
- **Multi-Purpose Building Rehabilitation** - P 1, 400, 000.00
(Typhoon Odette Damaged)
- **KALAHI – CIDSS Counterpart (Hard Infra Projects)** - P 400, 000.00

Total Amount for Re-alignment - P 3, 800, 000.00

Section 4. Effectivity. This Re-alignment Ordinance shall take effect immediately upon approval.




