## **MUNICIPAL ORDINANCE NO. 127-22**

Series of 2022

"AN ORDINANCE RE-ALIGNING & RE-PROGRAMMING THE 2021 UNUTILIZED 5% MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (MDRRMF) IN THE AMOUNT OF ONE MILLION THREE HUNDRED NINETY-SIX THOUSAND PESOS (P1,396.000.00) UNDER DISASTER PREPAREDNESS INTO DISASTER RESPONSE RELATIVE TO AFRICAN SWINE FEVER (ASF) INFESTATION IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE"

**WHEREAS**, the Municipality of San Benito, Siargao Island, Surigao del Norte was unfortunately besieged by the infestation of African Swine Fever (ASF) among backyard farms in the two Poblacion Barangays, where numerous number of hogs and swines were depopulated and annihilated accordingly;

WHEREAS, record from the Municipal Agriculture's Office revealed the summary of swine duly affected by ASF that were accordingly depopulated, to wit

a) Breeder - 18 heads
b) Boar - 2 heads
c) Gilt - 28 heads
d) Grower - 100 heads
e) Piglet - 57 heads
205 heads;

WHEREAS, presented for consideration is the 2021 Unutilized 5% Municipal Disaster Risk Reduction and Management Fund (MDRRMF) in the amount of One Million Three Hundred Ninety-Six Thousand Pesos (P1,396.000.00) under Disaster Preparedness to be re-aligned and re-programmed to Disaster Response relative to African Swine Fever (ASF) infestation in the municipality of San Benito, Siargao Island, Surigao del Norte;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Charlito E. Mendavia duly seconded by Sangguniang Bayan Member Felix B. Sumando, Sr.,

**BE IT ORDAINED,** by the 10<sup>th</sup> Sangguniang Bayan of San Benito, Siargao Island, Surigao del Norte in session assembled, that:

Section 1. Purpose. This Ordinance is intended to re-align and re-program the 2021 Unutilized 5% Municipal Disaster Risk Reduction and Management Fund (MDRRMF) in the amount of One Million Three Hundred Ninety-Six Thousand Pesos (P1,396.000.00) under Disaster Preparedness to be re-aligned and re-programmed to Disaster Response relative to African Swine Fever (ASF) infestation in the municipality of San Benito, Siargao Island, Surigao del Norte.

Section 2. Sources of Funds for Re-alignment and Re-program. The following are the unutilized 5% MDRRMF programs and projects for 2021 as sources for re-alignment, to wit:

## DISASTER PREPAREDNESS

Purchase of one (1) unit Rescue Vehicle - P 1, 400,000.00

Total Amount for Re-alignment - P 1, 400, 000.00

Section 3. Proposed Programs & Activities for Re-alignment and Re-program. The following are the proposed programs & activities for re-alignment based on the total aggregate amount of the 5% MDRRMF of 2021, to wit:

- 10 days Checkpoint (2 Poblacion Barangays) P 59, 000.00 (10 days Meals & Snacks for 10 persons @ P 590.00)
- 2 days Depopulation Activity
  - a) 2 days Meals & Snacks (2 meals, 2 snacks for 100 Persons @, P 940.00 x 10 days) - P 198, 500.00
  - b) Financial Assistance / Payment for depopulated pigs in varied amount depending on kilograms for 205 pigs/swine -

P 978, 500.00

96,000.00

- c) Backhoe rental for 2 days including mobilization -
- d) Hauling of depopulated pigs to burial site P 64,000.00

Total Amount for Re-alignment - P 1, 396, 000.00

Section 4. Effectivity. This Re-alignment Ordinance shall take effect immediately upon approval.
