MUNICIPAL ORDINANCE NO. 128-22

Series of 2022

“AN ORDINANCE CREATING FIVE (5) DIFFERENT REGULAR PLANTILLA POSITIONS IN THE MUNICIPAL GOVERNMENT OF SAN BENITO, SURIGAO DEL NORTE FOR FISCAL YEAR 2023 AND PROVIDING FUNDS THEREOF”

WHEREAS, the Office of the Municipal Mayor through the Municipal Development Council submitted to this Office the Local Expenditure Program (LEP) of the Municipality of San Benito, Surigao del Norte for Fiscal Year 2023 for this august body's review and authorization;

WHEREAS, presented for consideration is the proposed creation of five (5) different regular plantilla positions in the local government unit for Fiscal Year 2023 for purposes of efficient delivery of basic services to our constituents through hiring qualified employees based on merit and fitness;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Delfin P. Labola duly seconded by Sangguniang Bayan Member Felix B. Sumando, Sr., be it:

ENACTED by the 10th Sangguniang Bayan of San Benito, Surigao del Norte in session assembled, that:

Section 1. Purpose. This Ordinance is enacted for purposes of reinforcing and strengthening the pool of human resources who are qualified based on merit and fitness to join government service in order to achieve efficient and effective delivery of basic services, through creation of new plantilla positions in this local government unit.

Section 2. Creation of New Plantilla Positions and its Funding. There is hereby created new plantilla positions in this local government unit for Fiscal Year 2023 including appropriation of funds for salaries and other benefits thereof, to wit:

Section 3. Sources of Funds. The funding to be used for the newly created plantilla positions shall be sourced from the National Tax Allocation embodied in the General Appropriation Ordinance for FY 2023 of the Municipality of San Benito, Surigao del Norte;

Section 4. Effectivity. This Ordinance is effective for the whole duration of Calendar Year 2023 which shall commence from the first day of January 2023 and will cease to effect on the midnight of December 31, 2023;

RESOLVED FINALLY, that copies of this Ordinance be furnished to all concerned agencies for information and appropriate action;
