MUNICIPAL ORDINANCE NO. 130-22 Series of 2022

“AN ORDINANCE REQUIRING ALL CONSTRUCTION WORKERS OFFICIALLY HIRED BY ANY CONSTRUCTION COMPANIES / FIRMS OPERATING WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE TO SECURE A MAYOR’S WORKING PERMIT BEFORE THE START OF THE CONSTRUCTION PERIOD AND PAY A CORRESPONDING CALIBRATED PERMIT FEE RELEVANT THERETO”

BE IT ORDAINED BY THE 10TH SANGGUNIANG BAYAN OF SAN BENITO, SURIGAO DEL NORTE IN SESSION ASSEMBLED THAT:

Section 1. Title. This Ordinance shall be known and referred to as “An Ordinance Requiring All Construction Workers officially hired by any Construction Companies / Firms operating within the territorial jurisdiction of the Municipality of San Benito, Siargao Island, Surigao del Norte to secure a Mayor’s Working Permit before the start of the Construction Period and pay a corresponding Permit Fee relevant thereto.”

Section 2. Scope and Purpose. The enactment of this Ordinance is purposely intended to provide the construction workers duly hired by a construction company to be officially listed in the Local Employment Services Office of this municipality for inventory and for future interventions that

the government may provide. Moreover, this Working Permit will give assurance to the workers for safety and protection, while staying in the construction site. Thus this Ordinance is applicable to all Construction Workers officially hired by any Construction Companies / Firms operating within the territorial jurisdiction of the Municipality of San Benito, Siargao Island, Surigao del Norte.

Section 3. Calibrated Mayor's Working Permit Fee. For the construction worker whether bonafide resident of San Benito or coming from other places applying for a Mayor's Working Permit, he / she shall pay a corresponding calibrated Permit Fee once upon applying to the Municipal Treasury Office whose payment is good for the duration of one (1) year, to wit:

3.1 For bonafide resident of San Benito, Surigao del Norte:

Skilled Worker	P 300.00
Non-skilled Worker	P 100.00

3.2 For non-resident of San Benito, Surigao del Norte:

Skilled Worker	P 500.00
Non-skilled Worker	P 300.00

Section 4. Penalty Clause. Anyone found violating the provisions of this Ordinance shall be meted with a penalty of Two Thousand Pesos (P 2,000.00) in addition, he shall subject himself to apply for a Mayor's Working Permit and pay the corresponding Permit Fee.

Section 5. Repealing Clause. Any Ordinance or parts thereof, inconsistent with this enactment is hereby repealed or amended accordingly.

Section 6. Effectively Clause. This Ordinance shall take effect within fifteen (15) days after approval and posting in the bulletin board of the Municipal Building of San Benito and other conspicuous places.




