## MUNICIPAL ORDINANCE NO. 152 - 24 Series of 2024

"AN ORDINANCE RENAMING THE NEWLY CREATED PLANTILLA POSITION TITLE OF MUNICIPAL GOVERNMENT ASSISTANT DEPARTMENT HEAD I (SOCIAL WELFARE OFFICER IV) INTO MUNICIPAL GOVERNMENT ASSISTANT DEPARTMENT HEAD 1 (ASSISTANT SOCIAL WELFARE AND DEVELOPMENT OFFICER)"

WHEREAS, the Office of the municipal Mayor through the Human Resource Management Office (HRMO) submitted to this Office request for changing of position nomenclature for the newly created Plantilla position to conform with the correct and exact position title of the said position;

WHEREAS, this position is hereby created to complement with the pressing need of human resource of this municipality to handle the variety of works and the intricacies of social welfare and development services in the LGU;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member William A. Polican duly seconded by Sangguniang Bayan Member Felix B. Sumando, Sr.;

**BE IT ORDAINED,** by the 10<sup>th</sup> Sangguniang Bayan of San Benito, Siargao Island, Surigao del Norte in session assembled, that:

**Section 1. Title.** This Ordinance shall be known as the "Renaming of Position Title Ordinance in the Office of the Municipal Social Welfare and Development of this LGU."

**Section 2. Purpose.** The purpose of this Ordinance is to align the correct position title of the newly created position in the Office of the Municipal Social Welfare and Development of this municipality vis-à-vis the Civil Service Commission (CSC) rules and guidelines.

Section 3. Renaming of Position Title. This Sangguniang is hereby renaming the position title of Municipal Government Assistant Department Head I (Social Welfare Officer IV) into Municipal Government Assistant Department Head 1 (Assistant Social Welfare and Development Officer).

Section 4. Effectivity Clause. This ordinance shall take effect upon approval.

Let copies of this Ordinance be furnished to the Office of the Civil Service Commission (CSC) - SDN Field Office and the Office of the Municipal Mayor of San Benito, Surigao del Norte for information and guidance.
