MUNICIPAL ORDINANCE NO. 155 - 24

“AN ORDINANCE RENAMING THE NEWLY CREATED PLANTILLA POSITION TITLE OF LOCAL DISASTER RISK REDUCTION & MANAGEMENT OFFICER I INTO LOCAL DRRM OFFICER 1 AND NURSE ATTENDANT II INTO NURSING ATTENDANT II, IN CONFORMITY WITH THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) AND CIVIL SERVICE COMMISSION (CSC) INDEX ON OCCUPATIONAL SERVICES FOR LOCAL GOVERNMENT UNITS (IOS-LGU)”

WHEREAS, the Office of the Municipal Mayor through the Human Resource Management Office (HRMO) submitted to this Office request for changing of position nomenclature for the newly created Plantilla position to conform with the correct and exact position title of the said position;

WHEREAS, this position is hereby created to complement with the pressing need of human resource of this municipality to handle the variety of works and the intricacies of social welfare and development services in the LGU;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Felix B. Sumando, Sr. duly seconded by Sangguniang Bayan Member Charlito E. Mendavia;

BE IT ORDAINED, by the 10th Sangguniang Bayan of San Benito, Siargao Island, Surigao del Norte in session assembled, that:

Section 1. Title. This Ordinance shall be known as the "Renaming of Position Title Ordinance in the Office of the Municipal Disaster Risk Reduction & Management Officer and the Office of the Municipal Health Officer."

Section 2. Purpose. The purpose of this Ordinance is to align the correct position title of the newly created position in the Office of the Municipal Disaster Risk Reduction & Management Officer and the Office of the Municipal Health Officer of this municipality vis-à-vis the Civil Service Commission (CSC) rules and guidelines and DBM's Index for Occupational Services for LGU.

Section 3. Renaming of Position Title. This Sangguniang is hereby renaming the position title of the Local Disaster Risk Reduction & Management Officer 1 into **Local DRRM Officer 1** and the Nurse Attendant II into **Nursing Attendant II**.

Section 4. Effectivity Clause. This ordinance shall take effect upon approval.

Let copies of this Ordinance be furnished to the Office of the Civil Service Commission (CSC) - SDN Field Office and the Office of the Municipal Mayor of San Benito, Surigao del Norte for information and guidance.
