### **MUNICIPAL ORDINANCE NO. 156 - 24** Series of 2024

**“AN ORDINANCE RE-APPROPRIATING & RE-PROGRAMMING THE 2024 5% GENDER AND DEVELOPMENT (GAD) FUND APPROPRIATION IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (P 200,000.00) INTO OTHER INFRASTRUCTURE PROJECTS EQUALLY BENEFICIAL TO THE PEOPLE OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”**

**WHEREAS**, the Municipal GAD Council of San Benito recommends to this august body for re-appropriation and re-programming of the 5% GAD Fund of 2024 programs into other equally beneficial infrastructure projects for the benefit of the people of San Benito, which was duly endorsed by the Office of the Municipal Mayor through its letter requesting this body to enact a re-appropriation ordinance for this purpose;

**WHEREAS**, presented for consideration is the 2024 5% Gender and Development (GAD) Fund in the amount of Two Hundred Thousand Pesos (P200,000.00) to be re-appropriated and re-programmed to other equally beneficial infrastructure development projects of the municipality;

**WHEREFORE**, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Delfin P. Labola duly seconded by Sangguniang Bayan Member Felix B. Sumando, Sr.,

**BE IT ORDAINED**, by the 10<sup>th</sup> Sangguniang Bayan of San Benito, Siargao Island, Surigao del Norte in session assembled, that:

**Section 1. Purpose.** This Ordinance is intended to re-appropriate and re-program the 2024 5% Gender and Development (GAD) Fund in the amount of Two Hundred Thousand Pesos (P 200,000.00) into other equally beneficial infrastructure projects for the benefit of the people of San Benito, Siargao Island, Surigao del Norte.

**Section 2. Source of Funds for Re-appropriation and Re-program.** Below is the source of funds for re-appropriation and re-programming from the GAD Fund of 2024 with the following particulars:

**Section 3. Proposed Projects for Re-appropriation and Re-program.** The following are the proposed programs for re-appropriation based on the total amount of the 5% GAD Fund, to wit:

1. Construction of Pathway going to Poneas Hidden Lake, Comfort Rooms/Rest Rooms and Guest Reception Area	P 150,000.00
2. Family Day 2024 Activities	P 50,000.00
Total Amount for Re-appropriation	P 200,000.00


**Section 4. Effectivity.** This Re-appropriation Ordinance shall take effect immediately upon approval.




