MUNICIPAL ORDINANCE NO. 172 - 24 Series of 2024

“AN ORDINANCE RE-ALIGNING & RE-PROGRAMMING THE UNEXPENDED 5% MDRRM (CALAMITY) FUND FOR FY 2020, 2021 & 2022 IN THE TOTAL ACCUMULATED AMOUNT OF TWO MILLION THREE HUNDRED EIGHTY-NINE THOUSAND TWENTY-THREE PESOS AND EIGHTY-FOUR CENTAVOS (P2,389,023.84) INTO OTHER DISASTER RISK REDUCTION & MANAGEMENT PROGRAM ALLOCATION BENEFICIAL TO THE PEOPLE OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the Municipal DRRM Council of San Benito recommends to this august body for re-appropriation and re-programming of the Unexpended 5% MDRRM (Calamity) Fund of FY 2020, 2021 & 2022 programs into other equally beneficial DRRM Program Allocation for the benefits of the people of San Benito, which was duly endorsed by the Office of the Municipal Mayor through its letter requesting this body to enact a re-appropriation ordinance for this purpose;

WHEREAS, presented for consideration is the FY 2020, 2021 & 2022 5% MDRRM (Calamity) Fund which were not expended in the total amount of **TWO MILLION THREE HUNDRED EIGHTY-NINE THOUSAND TWENTY-THREE PESOS AND EIGHTY-FOUR CENTAVOS (P2,389,023.84)** to be re-appropriated and re-programmed to other equally beneficial MDRRM Program Allocation of the municipality;

WHEREAS, this august body finds no irregularities and inconsistencies in the submitted proposal for re-alignment and reprogramming, hence the enactment of this Ordinance;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Felix B. Sumando, Sr. duly seconded by LNMB President Ruella T. Rulete,

BE IT ORDAINED, by the 10th Sangguniang Bayan of San Benito, Siargao Island, Surigao del Norte in session assembled, that:

Section 1. Purpose. This Ordinance is intended to re-appropriate and re-program the Unexpended 5% MDRRM (Calamity) Fund for FY 2020, 2021 & 2022 in the total accumulated amount of **TWO MILLION THREE HUNDRED EIGHTY-NINE THOUSAND TWENTY-THREE PESOS AND EIGHTY-FOUR CENTAVOS (P2,389,023.84)** into other equally beneficial MDRRM Program Allocation for the benefits of the people of San Benito, Siargao Island, Surigao del Norte.

Section 2. Source of Funds for Re-appropriation and Re-program. Below is the source of funds for re-appropriation and re-programming from the Unexpended MDRRM Fund of 2020, 2021 & 2022 with the following particulars, to wit:






