RESOLUTION NO. 003 Series of 2023

“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND (BONGBONG) R. MARCOS, JR. THROUGH HONORABLE ANTONIO ERNESTO F. LAGDAMEO, JR., SPECIAL ASSISTANT TO THE PRESIDENT TO APPROPRIATE FUNDS IN THE TOTAL AMOUNT OF THIRTY MILLION PESOS (P 30,000,000.00) TO BE USED FOR THE CONSTRUCTION / INSTALLATION OF SOLAR – POWERED STREET LIGHTS (SOLAR LIGHT BARANGAY ELECTRIFICATION) OF BARANGAYS BONGDO, MARIBOJOC, NUEVO CAMPO, SAN JUAN, STA. CRUZ AND TALISAY ALL OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE AND SUBSEQUENTLY REQUESTING FOR ITS INCLUSION IN THE 2023 GENERAL APPROPRIATION ACT (GAA) LIST OF FUNDED PROJECTS”

WHEREAS, the people of Barangays Bongdo, Maribojoc, Nuevo Campo, San Juan, Sta. Cruz and Talisay all of the Municipality of San Benito, Siargao Island, Surigao del Norte since time immemorial are dreaming for a well-equipped lighting facilities along the streets of their respective barangays;

WHEREAS, for several years the streets of these six (6) barangays are always dim and dark during nighttime due to insufficient lighting facilities which are only relying on the electric cooperative's pole electrification found in every street corners;

WHEREAS, the Barangay Officials of these six (6) Barangay Local Government Units (BLGU) are always complaining for being not able to pay their monthly electric bills due to very limited financial resources of their barangays which led to repetitive power disconnection of their street lights;

WHEREAS, the constituencies of San Benito together with the local officials firmly believed that fully equipped lighting facilities in the locality is a major deterrence for juvenile delinquencies and criminalities along nighttime, hence the passage of this resolution;

WHEREAS, being a 6th-Class Municipality, construction / installation of Solar - Powered Street Lights in the six (6) barangays is very impossible to realize using only the very limited resources of this municipality, thus, financial aid from the Office of the President of the Republic of the Philippines, His Excellency Ferdinand R. Marcos, Jr. through his Special Assistant, Honorable Antonio Ernesto F. Lagdameo, Jr. is very vital and of paramount importance;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Delfin P. Labola duly seconded by Sangguniang Bayan Member William A. Polican, be it;


RESOLVED AS IT IS HEREBY RESOLVED to earnestly request His Excellency President Ferdinand (Bongbong) R. Marcos, Jr. through Honorable Antonio Ernesto F. Lagdameo, Jr., Special Assistant to the President to appropriate funds in the total amount of Thirty Million Pesos (P 30,000,000.00) to be used for the construction / installation of Solar – Powered Street Lights (Solar Light Barangay Electrification) of the following Barangays:


