“A RESOLUTION AUTHORIZING HONORABLE Ma. GINA SUMANDO – MENIL, LCB, MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO BETWEEN NUEVO CAMPO DEVELOPMENT COOPERATIVE (NUCADECO), REPRESENTED HEREIN BY ITS BOARD OF DIRECTOR CHAIRMAN, MR. DIOSDADO A. REQUIRME IN RELATION TO THE PROVISION OF FOOD AND NON-FOOD ITEMS TO COMPLEMENT THE NEEDS OF THE INTERNALLY DISPLACED PERSONS (IDP) DURING CALAMITIES IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the foremost goal of Republic Act No. 10121, also known as Philippine Disaster Risk Reduction and Management (PDRRM) Act of 2010 is to strengthen the country's National DRRM System towards sustainable economic development, by mainstreaming the same in all national and local development processes;

WHEREAS, as enshrined in the above quoted Republic Act, Section 12, sub paragraph (C - 16) the LDRRMC through the LDRRMO shall ... *“Respond to and manage the adverse effects of emergencies and carry out recovery activities in the affected area, ensuring that there is an efficient mechanism for immediate delivery of food, shelter, and medical supplies for women and children, endeavor to create a special place where internally displaced mothers can find help with breastfeeding, feed and care for their babies and give support to each other.”*;

WHEREAS, in pursuance to the provision of the law, it is hereby proper to grant authorization to the Local Chief Executive, Honorable Ma. Gina Sumando – Menil, LCB to enter into a Memorandum of Agreement (MOA) and sign in behalf of the Municipal Government of San Benito with Nuevo campo Development cooperative (NUCADECO), herein represented by its Board of Director Chairmen, Mr. Diosdado A. Requirme for the provision of Food and Non-Food Items to complement the needs of those internally displaced individuals during the onslaught of any calamities and disasters in the municipality, hence the adoption of this resolution;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Cindy R. Agati duly seconded by Sangguniang Bayan Member Felix B. Sumando, Sr., be it;

RESOLVED AS IT IS HEREBY RESOLVED to authorize Honorable Ma. Gina Sumando – Menil, LCB, Municipal Mayor to enter into a Memorandum Of Agreement (MOA) and sign in behalf of the Municipal Government of San Benito between Nuevo Campo Development Cooperative (NUCADECO), represented herein by its Board of Director Chairman, Mr. Diosdado A. Requirme in relation to the provision of Food and Non-Food Items to complement the needs of the Internally Displaced Persons (IDP) during calamities in the Municipality of San Benito, Siargao Island, Surigao del Norte;

RESOLVED FINALLY, that copies of this resolution be furnished the Office of the Municipal Mayor of San Benito, Surigao del Norte together with all concerned offices for information and guidance;


