WHEREAS, the Municipality of San Benito, Surigao del Norte is one of the recipient municipalities in the region to avail the Early Childhood Care and Development (ECCD) Program of the Department of Social Welfare and Development (DSWD);

WHEREAS, the “Supplementary Feeding Program” is the provision of food in addition to the regular meals, to currently enrolled day care children as part of DSWD’s contribution to the ECCD Program of the government;

WHEREAS, this above mentioned program is being grounded on several national laws and statutes especially enacted for the promotion and protection of children in the country and in cognizance of the beneficial effects of this program to the day care children of San Benito, hence the adoption of this resolution;




