**“A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE Ma. GINA SUMANDO – MENIL, LCB TO INTER INTO A MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) THROUGH THE PROVINCIAL TRAINING CENTER-SIARGAO (PTC-SIARGAO) REPRESENTED BY ITS REGIONAL DIRECTOR, TARHATA S. MAPANDI, RPF, MPA, CESO III AND THE LOCAL GOVERNMENT UNIT OF SAN BENITO (LGU-SAN BENITO), SURIGAO DEL NORTE, REPRESENTED HEREIN BY ITS LOCAL CHIEF EXECUTIVE, HON. Ma. GINA SUMANDO – MENIL, LCB”**

**WHEREAS**, pursuant to Section 444 (vi) of the R.A. 7160, the Local Chief Executive upon authorization of the Sangguniang Bayan, represents the municipality in all its business transactions and sign on its behalf all bonds, contracts and obligations and such other documents made pursuant to the law or ordinance;

**WHEREAS**, the Technical Education and Skills Development Act or (R.A. 7796) and its implementing Rules and Regulations mandates the TESDA to promote strengthened linkages between education/training institutions and industry to ensure that appropriate skills and knowledge are provided by the educational system;

**WHEREAS**, the PTC-Siargao identifies LGU- San Benito of Brgys. Sta. Cruz & Talisay, Poblacion, San Benito, Surigao del Norte as the training partner under the Mobile Training Program (MTP) and jointly apply for accreditation with TESDA for the following programs:

ORGANIC AGRICULTURE PRODUCTION (OAP) NC II; FOOD PROCESSING NC II; AGRICULTURAL CROP PRODUCTION (ACP) NC I and NC III; SHIELDED METAL ARC WELDING (SMAW) NC I and NC II; DRIVING NC II; TRAINERS METHODOLOGY (TM) LEVEL I and LEVEL II; CARPENTRY NC II and MASONRY NC II;

**WHEREAS**, the august body finds it reasonable and justifiable to grant an authority to the Local Chief Executive of Hon. Ma. Gina Sumando – Menil, LCB for the above-mentioned purpose;

**WHEREFORE**, on motion of Sangguninag Bayan Member Felix B. Sumando, Sr. and duly seconded by Sangguniang Bayan Member Aldrein C. Glimane during the regular session assembled, be it;


