

RESOLUTION EARNESTLY "A REQUESTING EXCELLENCY PRESIDENT FERDINAND "BONGBONG" R. MARCOS, JR THROUGH HONORABLE SENATOR JUAN MIGUEL F. ZUBIRI, SENATE PRESIDENT, SENATE OF THE PHILIPPINES (19<sup>TH</sup> CONGRESS) TO ALLOCATE FUNDS AS FINANCIAL ASSISTANCE IN THE AMOUNT OF FIVE MILLION PESOS (P 5,000,000.00) TO BE USED FOR THE CONSTRUCTION OF **MULTI-PURPOSE** BUILDING (COVERED COURT) OF BARANGAY SAN JUAN, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE "

WHEREAS, the existing Multi-Purpose Building (covered court) of Brgy. San Juan, San Benito, Siargao Island, Surigao del Norte is already dilapidated being made only of woods and it is now currently vacated and condemned for several years due to very fragile structural bearing that could never withstand during occurrences of typhoons, earthquakes and other weather disturbances;

WHEREAS, the multi-purpose building (covered court) will serve as the venue for sports activities and any public gatherings and ceremonies in the locality where people congregate in order to join, participate and engage in such affairs that will promote communal and multi-stakeholders' participation;

**WHEREAS**, being a 6<sup>th</sup>-Class LGU, construction of a new and concrete Multi-Purpose Building (covered court) is very impossible to realize using only the very limited resources of

this municipality; thus, financial assistance from the Office of the Senate President of the Philippines (19th Congress) is very vital and of paramount importance;

RESOLVED AS IT IS HEREBY RESOLVED to earnestly request His Excellency President Ferdinand "Bongbong" R. Marcos, Jr through Honorable Senator Juan Miguel F. Zubiri, Senate President, Senate of the Philippines (19th Congress) to allocate funds as financial assistance in the amount of Five Million Pesos (P 5,000,000.00) to be used for the Construction of Multi-Purpose Building (Covered Court) of Barangay San Juan, San Benito, Siargao Island, Surigao del Norte:
