### **RESOLUTION NO. 022**

**“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND “BONGBONG” R. MARCOS, JR THROUGH HONORABLE AMENAH F. PANGANDAMAN, SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE FUNDS AS FINANCIAL ASSISTANCE IN THE TOTAL AMOUNT OF THIRTY MILLION PESOS (₱ 30,000,000.00) TO BE USED FOR THE PROCUREMENT OF ONE (1) UNIT GARBAGE COMPACTOR (6-WHEELER), ONE (1) UNIT BACKHOE LOADER AND ONE (1) UNIT DUMP TRUCK (10 – WHEELER) FOR PURPOSES OF EFFECTIVE IMPLEMENTATION OF THE ECOLOGICAL SOLID WASTE MANAGEMENT PROGRAM IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”**

**WHEREAS**, one of the salient features of the Ecological Solid Waste Management Act or R.A. 9003 is the mandate among local government units to intensify its solid waste management efforts, resource conservation, source reduction, segregation to collection of solid wastes and special wastes which will be brought to the buy-back centers going to the controlled dump sites or sanitary landfill areas of each LGU;

**WHEREAS**, collection of garbage is one of the most crucial aspect of solid waste management, wherein a need of a more systematic and cost effective collection strategy is to be employed to ensure effective garbage collection, thus a garbage compactor (6 wheelers), backhoe loader and a dump truck (10 wheelers) are of paramount importance;

**WHEREAS**, the Municipality of San Benito, Siargao Island, Surigao del Norte is just a 6<sup>th</sup> Class LGU operating only within its very limited financial resources and very constraints budgetary allocations, procurement of a garbage compactor (6 wheelers), backhoe loader and a dump truck (10 wheelers) using its meager resources is an absolute futility, thus financial assistance from the President of the Republic of the Philippines, through the Office of the DBM Secretary is very essential and of vital importance;


**WHEREFORE**, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member William A. Polican duly seconded by Sangguniang Bayan Member Felix B. Sumando, Sr., be it,

**RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request His Excellency Ferdinand “Bongbong” R. Marcos, Jr., President of the Republic of the Philippines through Honorable Amenah F. Pangandaman, Secretary of the Department of Budget and Management (DBM) to appropriate funds in the total amount of **Thirty Million Pesos (P 30,000,000.00)** for the Procurement Of One (1) Unit Garbage Compactor (6-Wheeler), One (1) Unit Backhoe Loader and One (1) Unit Dump Truck (10 – Wheeler) for purposes of effective implementation of the Ecological Solid Waste Management Program in the Municipality of San Benito, Siargao Island, Surigao del Norte, with the following breakdown:


