**“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND “BONGBONG” R. MARCOS, JR THROUGH HONORABLE KRISTINE Y. EVANGELISTA, ASSISTANT SECRETARY FOR CONSUMER AFFAIRS AND SPOKESPERSON OF THE DEPARTMENT OF AGRICULTURE (DA) TO ALLOCATE FUNDS AS FINANCIAL ASSISTANCE IN THE TOTAL AMOUNT OF FIVE MILLION PESOS (P 5,000,000.00) TO BE USED FOR THE PROCUREMENT OF TWO (2) UNITS OF HAULING TRUCK FOR PURPOSES OF TRANSPORTING AGRICULTURAL PRODUCTS FROM THE SOURCE (FARM) GOING TO THE MARKET (KADIWA STORE) IN LINE WITH THE IMPLEMENTATION OF THE ENHANCED KADIWA NI ANI AT KITA PROGRAM IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”**

**WHEREAS,** the Municipal Government of San Benito, Siargao Island, Surigao del Norte is one of the recipient LGUs in the country to be granted with the Enhanced KADIWA ni Ani at Kita Program of the Department of Agriculture (DA) through a recognized People's Organization and Farmer Cooperative operating in the municipality;

**WHEREAS**, the KADIWA is a marketing initiative of the Department of Agriculture implemented through the Agribusiness and Marketing Assistance (AMAS), which seeks to empower the farming community by providing a direct and effective farm – to – consumer food supply chain;

**WHEREAS**, to effectively implement the purpose of the Enhanced KADIWA ni Ani at Kita Program, the Municipal Government of San Benito intend to free our marginal farmers especially in the far-flung barangays from hassle and discomfort in transporting their agricultural produced going to the market or in the KADIWA Store, thus a hauling truck (vehicle) is very vital and of paramount importance;








Evangelista, Assistant Secretary for Consumer Affairs and Spokesperson of the Department of Agriculture (DA) is of vital importance;

**WHEREFORE**, foregoing premises considered and upon the motion of the Sangguniang Bayan Member Felix B. Sumando, Sr. duly seconded by Sangguniang Bayan Member Cindy R. Agati, be it;

**RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request His Excellency President Ferdinand “Bongbong” R. Marcos, Jr through Honorable Kristine Y. Evangelista, Assistant Secretary for Consumer Affairs and Spokesperson of the Department of Agriculture (DA) to allocate funds as financial assistance in the total amount of Five Million Pesos (P 5,000,000.00) to be used for the Procurement of Two (2) Units of Hauling Truck for purposes of transporting agricultural products from the source (farm) going to the market (KADIWA Store) in line with the implementation of the Enhanced KADIWA Ni Ani At Kita Program in the Municipality of San Benito, Siargao Island, Surigao del Norte;


