RESOLUTION NO. 037 Series of 2023

“A RESOLUTION EARNESTLY REQUESTING HONORABLE LORNA REGINA “LOREN” B. LEGARDA, SENATE PRESIDENT PRO TEMPORE, SENATE OF THE PHILIPPINES (19TH CONGRESS), CHAIR – SENATE CULTURE AND THE ARTS COMMITTEE TO ALLOCATE FUNDS AS FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN MILLION PESOS (₱ 10,000,000.00) FOR THE REPAIR / REHABILITATION OF SAN BENITO MULTI-PURPOSE BUILDING (SAN BENITO WOMEN’S CENTER) OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE BEING SEVERELY DAMAGED BY SUPER TYPHOON ODETTE”

WHEREAS, on December 16, 2021 at around 11:00 o'clock in the morning until 5:00 o'clock in the afternoon, the whole island of Siargao including the whole municipality of San Benito was hit by Super Typhoon “Odette” with an international name “Rai” at its maximum gustiness and sustained wind of 295 kph, classifying it as Super Typhoon category and hoisting the whole province of Surigao del Norte with Typhoon Signal Warning # 5;

WHEREAS, the onslaught of Super Typhoon Odette brought severe damages to the people of this municipality based on the result of the Rapid Damage Needs Assessment (RDNA) conducted by the composite team of MDRRMO, MSWDO, MEO and MAO, which revealed that 100% of the total population were considered Internally Displaced Persons (IDPs) and that all of the six barangays means of livelihood (fishing & farming) including shelters and infrastructure projects owned by the government and private individuals were greatly devastated and severely damaged;

WHEREAS, the San Benito Multi-Purpose Building (San Benito Women’s Center) was one of the many government buildings and edifices that were severely damaged, that definitely needs total repair /rehabilitation, however due to very limited income of the Municipality being considered a 6th class LGU, it could not fund its own rehabilitation, hence the adoption of this resolution of financial assistance from the Chairman of the Senate Culture and the Arts Committee and the Senate President Pro Tempore, Sen. Legarda;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Cindy R. Agati duly seconded by Sangguniang Bayan Member Jayrom P. Caballejos, be it;

RESOLVED AS IT IS HEREBY RESOLVED to earnestly request Honorable Lorna Regina “Loren” B. Legarda, Senate President Pro Tempore, Senate of the Philippines (19th Congress), Chair – Senate Culture and the Arts Committee to allocate funds as financial assistance in the amount of Ten Million Pesos (₱ 10,000,000.00) for the Repair / Rehabilitation of San Benito Multi-Purpose Building (San Benito Women’s Center) Of The Municipality of San Benito, Siargao Island, Surigao del Norte being severely damaged by Super Typhoon Odette;


