“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND “BONGBONG” R. MARCOS, JR. THROUGH HONORABLE JUAN EDGARDO “SONNY” M. ANGARA, SENATOR OF THE REPUBLIC OF THE PHILIPPINES, CHAIR – SENATE COMMITTEE ON FINANCE & YOUTH (19TH CONGRESS) TO APPROPRIATE FUNDS AS FINANCIAL ASSISTANCE TO THE LOCAL GOVERNMENT UNIT OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE IN THE TOTAL AMOUNT OF SIXTY MILLION PESOS (₱ 60,000,000.00) THAT WILL BE USED FOR THE CONCRETING OF THE BARANGAY ROADS OF THE SIX COMPONENT BARANGAYS OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE WITH TEN MILLION PESOS (₱ 10,000,000.00) PER BARANGAY”

WHEREAS, majority of the existing barangay roads in the six different barangays of San Benito for the longest time remains in its earthen state and were never cemented thereby, causing discomfort among road users, pedestrians and motor vehicles especially during heavy downpour and bad weather condition;

WHEREAS, this deplorable condition of the barangay roads of San Benito exacerbated the prolonged agony of the people especially those living in the far-flung areas which definitely impacted their current living condition;

WHEREAS, concreting of these barangay roads definitely bring economic return to the people of the six barangays of this municipality, for this will provide easy access of bringing their farm and fishery products down to nearby public market;

WHEREAS, all these barangays have its own identified tourist destinations that contributed to the overall tourism sector of the Municipality of San Benito, thus improvement in its road network is very vital and of paramount importance in boosting the tourism industry in this area;

WHEREAS, the Municipality of San Benito, being a 6th- class LGU definitely could not finance construction of such project using only its limited resources, thus financial intervention and help from the good Office Honorable Senator Sonny M. Angara is in dire need and of paramount importance:







