**“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND “BONGBONG” R. MARCOS, JR. THROUGH HONORABLE MARIA IMELDA JOSEFA REMEDIOS “IMEE” R. MARCOS, SENATOR OF THE REPUBLIC OF THE PHILIPPINES (19<sup>TH</sup> CONGRESS), CHAIR – SENATE SOCIAL JUSTICE, WELFARE AND RURAL DEVELOPMENT COMMITTEE TO ALLOCATE FUNDS AS FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY MILLION PESOS (P 30,000,000.00) FOR THE CONCRETING OF SITIO DAPANAS TO MUNICIPAL SLAUGHTERHOUSE ACCESS ROAD OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”**

**WHEREAS**, the Municipality of San Benito has its slaughterhouse located at Sitio Dapanas, Brgy. Talisay which is quiet a distance from the nearest community and from the poblacion – San Benito, where such facility is being maintained and operated by the Municipal Government of San Benito;

**WHEREAS**, the access road going to the slaughterhouse facility is for the longest time remains in its earthen state, very deplorable and were never concreted / cemented thereby, causing discomfort among road users and motor vehicles carrying butchered meat going in and out from the facility especially during heavy downpour and bad weather condition;

**WHEREAS**, being a 6<sup>th</sup>- class LGU, the Municipal Government definitely could not finance construction of such project using only its limited resources, thus financial intervention and help from the good Office of Honorable Senator Imee R. Marcos is in dire need and of paramount importance:






