“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND “BONGBONG” R. MARCOS, JR. THROUGH HONORABLE MARIA IMELDA JOSEFA REMEDIOS “IMEE” R. MARCOS, SENATOR OF THE REPUBLIC OF THE PHILIPPINES (19TH CONGRESS), CHAIR – SENATE SOCIAL JUSTICE, WELFARE AND RURAL DEVELOPMENT COMMITTEE TO ALLOCATE FUNDS AS FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED MILLION PESOS (₱ 100,000,000.00) FOR THE CONCRETING OF 4 KILOMETERS SAN BENITO – NUEVO CAMPO TOURISM ROAD / LOCAL ACCESS ROAD GOING TO SAN BENITO PORT OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the 4 - Kilometer San Benito – Nuevo Campo Road is considered as Farm-to-Market Road and at the same time a Tourism Local Access Road going to San Benito Port;

WHEREAS, the San Benito - Nuevo Campo Tourism Access Road once concreted will definitely connect the tourist entering Siargao Island to San Benito and the Siargaonons in general from the Municipalities of Burgos, Pilar and San Isidro to all the tourist destinations of San Benito, Siargao Island and further connect them to the port of San Benito, where tourist boats are currently stationed at;

WHEREAS, for almost two (2) decades, this road really needs to be concreted for the reason that it is very impassable, muddy and unsafe for the tourist to come to San Benito and also our poor farmers have very difficult time in transporting their farm products to the Municipal

Public Market and that they were compelled to use another route passing through the Municipalities of San Isidro and Del Carmen respectively;

WHEREAS, due to this prevailing situation the agony of the farmers of San Benito are being aggravated and that this lead to their economic losses due to high cost of transportation and long way travel, thus a need of immediate concreting of that road is very vital and of paramount importance;

WHEREAS, the Municipal Government of San Benito, being a 6th Class LGU and in cognizance of its very limited resources it could not definitely finance its construction, thus financial help and assistance from the highest official of the land, the President of the Republic of the Philippines, His Excellency Ferdinand “Bongbong” R. Marcos, Jr. through Honorable Secretary of the Department of Public Works and Highways (DPWH) is very vital and of paramount importance;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Cindy R. Agati duly seconded by Sangguniang Bayan Member Puyat P. Sumando, be it;

RESOLVED AS IT IS HEREBY RESOLVED to earnestly request His Excellency President Ferdinand “Bongbong” R. Marcos, Jr. through Honorable Maria Imelda Josefa Remedios “Imee” R. Marcos, Senator of the Republic of the Philippines (19th Congress), Chair – Senate Social Justice, Welfare and Rural Development Committee to allocate funds as Financial Assistance in the amount of One Hundred Million Pesos (₱ 100,000,000.00) for the Concreting of 4 Kilometers San Benito – Nuevo Campo Tourism Road / Local Access Road going to San Benito Port of the Municipality of San Benito, Siargao Island, Surigao del Norte






