“A RESOLUTION GRANTING AUTHORITY TO THE MUNICIPAL MAYOR, HON. Ma. GINA SUMANDO – MENIL, LCB TO ENTER INTO AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO WITH THE DEPARTMENT OF HEALTH (DOH) – REGION XIII, REPRESENTED BY DIRECTOR CESAR C. CASSION, MD, MPH, CESO III IN RELATION TO THE IMPLEMENTATION OF THE GRANT OF HEALTH EMERGENCY ALLOWANCE (HEA) FOR OUR RURAL HEALTH UNIT PERSONNEL IN THE MUNICIPALITY OF SAN BENITO, SURIGAO DEL NORTE”

WHEREAS, submitted for consideration of this august body the letter-request from the Office of the Mayor and the draft Memorandum Of Agreement (MOA) for the implementation of the Health Emergency Allowance (HEA) in the Municipality of San Benito, Siargao Island, Surigao del Norte specifically granting the Municipal Mayor, Hon. Ma. Gina Sumando-Menil, LCB authorization to enter into and sign in behalf of the Municipal Government of San Benito unto this said agreement;

WHEREAS, this Health Emergency Allowance (HEA) is in consonance to the provision of R.A. 11712, also known as the Public Health Emergency Benefits and Allowances for Health Care Workers Act, which provide the payment of Health Emergency Allowance (HEA), Sickness & Death Compensation and other Benefits for public and private health care workers (HCWs) and non HCWs during the COVID-19 Pandemic and other future public health emergencies with retroactive application starting July 1, 2021;

WHEREAS, the fund source of this project is from the national government through the Department of Health (DOH) wherein funds appropriated are to be downloaded to the account of the LGU concerned for proper disbursement to the qualified and eligible HCWs and non-HCWs in the municipality;


WHEREAS, this particular HEA will vary depending on the risk exposure categorization of the HCWs and non-HCWs in particular setting: ₱ 3,000.00 for low risk, ₱ 6,000.00 for medium risk and ₱ 9,000.00 for high risk;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Charlito E. Mendavia duly seconded by Sangguniang Bayan Member Cindy R. Agati, be it;



RESOLVED AS IT IS HEREBY RESOLVED to grant authority to the Municipal Mayor, Hon. Ma. Gina Sumando – Menil, LCB to enter into and sign in behalf of the Municipal Government of San Benito with the Department of Health (DOH) – Region XIII, represented by Director Cesar C. Cassion, MD, MPH, CESO III in relation to the implementation of the grant of Health Emergency Allowance (HEA) for our Rural Health Unit Personnel in the Municipality of San Benito, Surigao del Norte


