"A RESOLUTION DECLARING VALID AND OPERATIVE APPROPRIATION ORDINANCE NO. 01 SERIES OF 2023 OF BARANGAY NUEVO CAMPO, SAN BENITO, SURIGAO DEL NORTE, ENACTING ITS GENERAL FUND ANNUAL BUDGETS FOR CALENDAR YEAR 2023 IN THE TOTAL AMOUNT OF THREE MILLION TWO HUNDRED FORTY THOUSAND THREE HUNDRED FORTY-EIGHT PESOS AND SIXTY-SIX CENTAVOS (P 3,240,348.66)"

WHEREAS, submitted for consideration of this august body the Appropriation Ordinance No. 01 s. 2023 of Barangay Nuevo Campo, San Benito, Surigao del Norte, containing the General Fund Annual Budget for Calendar Year 2023 in the total amount of THREE MILLION TWO HUNDRED FORTY THOUSAND THREE HUNDRED FORTY-EIGHT PESOS AND SIXTY-SIX CENTAVOS (P 3,240,348.66) " for review and study of this body;
