"A RESOLUTION DECLARING VALID AND OPERATIVE APPROPRIATION ORDINANCE NO. 01 SERIES OF 2023 OF BARANGAY STA. CRUZ, SAN BENITO, SURIGAO DEL NORTE, ENACTING ITS GENERAL FUND ANNUAL BUDGETS FOR CALENDAR YEAR 2023 IN THE TOTAL AMOUNT OF THREE MILLION THREE HUNDRED SIX THOUSAND THREE HUNDRED THIRTY PESOS (P 3, 306, 330.00)"

WHEREAS, submitted for consideration of this august body the Appropriation Ordinance No. 01 s. 2023 of Barangay Sta.
