**“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND “BONGBONG” R. MARCOS, JR. THROUGH HONORABLE MANUEL “LITO” M. LAPID, SENATOR OF THE REPUBLIC OF THE PHILIPPINES, CHAIR – SENATE COMMITTEE ON GAMES & AMUSEMENT (19<sup>TH</sup> CONGRESS) TO APPROPRIATE FUNDS AS FINANCIAL ASSISTANCE TO THE LOCAL GOVERNMENT UNIT OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE IN THE AMOUNT OF THIRTY MILLION PESOS (P 30,000,000.00) THAT WILL BE USED FOR THE CONSTRUCTION OF 2-STOREY SANGGUNIANG KABATAAN MULTI-PURPOSE BUILDING TO BE LOCATED AT BRGY. TALISAY, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”**

Lapid is in dire need and of paramount importance:






