"A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND "BONGBONG" R. MARCOS, JR. THROUGH HONORABLE MANUEL "LITO" M. LAPID, SENATOR OF THE REPUBLIC OF THE PHILIPPINES, CHAIR – SENATE COMMITTEE ON GAMES & AMUSEMENT (19TH CONGRESS) TO APPROPRIATE FUNDS AS FINANCIAL ASSISTANCE TO THE LOCAL GOVERNMENT UNIT OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE IN THE AMOUNT OF TWENTY-FIVE MILLION PESOS (₱ 25,000,000.00) THAT WILL BE USED FOR THE CONSTRUCTION OF 2-STOREY EVACUATION CENTER TO BE LOCATED AT BRGY. TALISAY, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE"

WHEREAS, the Municipality of San Benito, Siargao Island, Surigao del Norte is one of the nine (9) coastal municipalities in Siagao Island topographically located at the northwestern portion of Siargao and is always prone with storm surges, saltwater intrusion and landslide, making it vulnerable to any climatological changes occurring in the area;

WHEREAS, for longest time, the municipality of San Benito has no evacuation center equipped with facilities where to evacuate our affected residents during the onslaught of typhoons, heavy rains and very bad weather condition that really brought havoc to the lives of the people in coastal and landslide prone areas;

WHEREAS, the Municipality of San Benito, being a 6th- class LGU definitely could not finance the construction of this project using only the limited resources of the LGU, thus financial intervention and help from the good Office of Honorable Senator Lito M. Lapid is in dire need and of paramount importance:

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Delfin P. Labola duly seconded by SK Federated President Delcy Rose S. Plandano, be it;

RESOLVED AS IT IS HEREBY RESOLVED to earnestly request His Excellency Ferdinand "Bongbong" R. Marcos, Jr., President of the Republic of the Philippines through Honorable Manuel "Lito" M. Lapid, Senator of the Republic of the Philippines, Chair – Senate Committee on Games & Amusement (19th Congress) to appropriate funds as Financial Assistance to the Local Government Unit of San Benito, Siargao Island, Surigao del Norte in the amount of Twenty-Five Million Pesos (P 25,000,000.00) that will be used for the Construction of 2-Storey Evacuation Center to be located at Brgy. Talisay, San Benito, Siargao Island, Surigao del Norte;
