APPROPRIATE FUNDS AS FINANCIAL ASSISTANCE TO THE
LOCAL GOVERNMENT UNIT OF SAN BENITO, SIARGAO
ISLAND, SURIGAO DEL NORTE IN THE AMOUNT OF TWENTY-
FIVE MILLION PESOS (P 25,000,000.00) THAT WILL BE USED FOR

WHEREAS, the Municipality of San Benito, Siargao Island, Surigao del Norte is one of the nine (9) coastal municipalities in Siargao Island topographically located at the northwestern portion of Siargao and is always prone with storm surges, saltwater intrusion and landslide, making it vulnerable to any climatological changes occurring in the area;

WHEREAS, for longest time, the municipality of San Benito has no evacuation center equipped with facilities where to evacuate our affected residents during the onslaught of typhoons, heavy rains and very bad weather condition that really brought havoc to the lives of the people in coastal and landslide prone areas;







