**WHEREAS**, the owner and proprietor of the proposed E.M. Gasoline Station, Mr. Elmer Q. Poculan submitted the required documents to this Office for the endorsement purposes to the Protected Area Management Board (PAMB) of DENR-SIPLAS with regard to their application for the issuance of an Environmental Compliance Certificate;




