“A RESOLUTION GRANTING AUTHORITY TO THE MUNICIPAL MAYOR, HONORABLE Ma. GINA SUMANDO – MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO BETWEEN THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) – PROVINCIAL TRAINING CENTER - SIARGAO REPRESENTED BY MS. CATALINA O. TACUBAO, PROVINCIAL DIRECTOR IN RELATION TO THE PARTNERSHIP AGREEMENT BEING A PROVIDER OF TECHNICAL EDUCATION AND SKILLS DEVELOPMENT OF ALL IDENTIFIED PERSONS WHO USED DRUGS (PWUDS) IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE VIS-A-VIS COMMUNITY BASED DRUG REHABILITATION PROGRAM (CBDRP) IMPLEMENTATION”

WHEREAS, the Municipality of San Benito, Siargao Island is one of the many LGUs in the country having constituents or individuals being identified and recognized to be users of illegal drugs who eventually surrendered known as Persons Who Used Drugs (PWUDs);

WHEREAS, these individuals considered as PWUDs need to be rehabilitated and should be included in the Community Based Drug Rehabilitation Program (CBDRP), a holistic approach in rehabilitating the surrendered drug personalities and aims to focus on the healing of the body, mind, and soul through counseling and other therapeutic sessions;

WHEREAS, in an effort to strengthen the implementation of CBDRP, the Municipal Government of San Benito through the Municipal Anti-Drug Abuse Council (MADAC) need to coordinate, collaborate and establish linkages between individuals/personalities, institutions, organizations known to have capacities and specialization in providing screening, treatment, recovery and family support, and aftercare and reintegration of these drug surrendered personalities;

WHEREAS, the Technical Education and Skills Development Authority (TESDA) Provincial Training Center-Siargao is a National Government Agency capable of providing opportunities in obtaining technical education and skills development, aftercare and reintegration services of the identified PWUDs;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member William A. Polican duly seconded by Sangguniang Bayan Member Puyat P. Sumando, be it,

RESOLVED AS IT IS HEREBY RESOLVED to grant authority to the Municipal Mayor, Honorable Ma. Gina Sumando – Menil, LCB and sign in behalf of the Municipal Government of San Benito between the Technical Education And Skills Development Authority (TESDA) – Provincial Training Center - Siargao represented by Ms. Catalina O. Tacubao, Provincial Director in relation to the partnership agreement being a provider of Technical Education and Skills Development for all identified Persons Who Used Drugs (PWUDs) in the Municipality of San Benito, Siargao Island, Surigao del Norte vis-a-vis Community Based Drug Rehabilitation Program (CBDRP) implementation;

RESOLVED FINALLY to furnish copies of this resolution the Office of the Municipal Mayor, Hon. Ma. Gina S. Menil, LCB, 2nd Floor - Municipal Hall Bldg., Brgy. Sta. Cruz, San Benito, Surigao del Norte and all concerned agencies for information and appropriate action;




