GINA SUMANDO – MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO BETWEEN THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP)- SIARGAO BRANCH, REPRESENTED BY ITS MANAGER, MS. JESILY A. REJUSO IN RELATION TO THE SALARY LOAN PROGRAM OFFERED BY THE BANK FOR THE MUNICIPAL OFFICIALS AND EMPLOYEES OF THIS LOCAL GOVERNMENT UNIT”**

**WHEREAS**, the Development Bank of the Philippines (DBP) – Siargao Branch is the official Depository Bank of the Municipal Government of San Benito, Surigao del Norte;


