### **RESOLUTION NO. 086** Series of 2023

**“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND “BONGBONG” R. MARCOS JR, THROUGH HONORABLE MANUEL M. BONOAN, SECRETARY OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO EXTEND FINANCIAL ASSISTANCE TO THE MUNICIPAL GOVERNMENT OF SAN BENITO IN THE AMOUNT OF FORTY-FIVE MILLION PESOS (P 45,000,000.00) TO BE USED FOR THE CONSTRUCTION OF THE ADDITIONAL PHASE OF THE ON-GOING FLOOD CONTROL PROJECT OF BRGY. NUEVO CAMPO, SAN BENITO, SURIGAO DEL NORTE”**

**WHEREAS**, the construction of the flood control project in Barangay Nuevo Campo is currently going on and its 1<sup>st</sup> phase component is about to finish, however it needs another phase to fully complete the construction of said facility, making it fully operational to the public;

**WHEREAS**, this flood control facility is a long cherish dream project of our people that finally come into reality; an infrastructure intervention that undisputedly provide solution to the perennial problem of flooding that caused the whole community to suffer the effects of loss of income, damage to properties and water-borne diseases brought by the constant inundation of water;

**WHEREAS**, the continuation of this noble project in Brgy. Nuevo Campo would necessarily mean expansion of the length of project coverage, enabling the whole community to

be protected it its maximum level, thus another phase and another funding is accordingly of vital importance;

**WHEREAS**, the LGU-San Benito being a 6<sup>th</sup> class Municipality is absolutely incapacitated to continue the construction of the 2<sup>nd</sup> phase using its own resources due to very limited financial capacity, thus financial assistance especially from the Office of the good Secretary of the Department of Public Works and Highways (DPWH), Hon. Manuel M. Bonoan is direly sought and prayed for;

Bonoan, Secretary of the Department of Public Works and Highways (DPWH) to extend financial assistance to the Municipal Government of San Benito in the amount of Forty-Five Million Pesos (₱ 45,000,000.00) to be used for the Construction of the Additional Phase of the on-going Flood Control Project of Brgy. Nuevo Campo, San Benito, Surigao del Norte;
