

“A RESOLUTION EARNESTLY REQUESTING HONORABLE UNDERSECRETARY ARIEL F. NEPOMUCENO, ADMINISTRATOR & EXECUTIVE DIRECTOR, OFFICE OF THE CIVIL DEFENSE (OCD) OF THE DEPARTMENT OF NATIONAL DEFENSE (DND) THROUGH DIRECTOR LIZA R. MAZO, OCD-CARAGA REGION XIII TO ALLOCATE FUNDS AS FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY MILLION PESOS (P 30,000,000.00) TO BE USED FOR THE CONSTRUCTION OF A TWO (2) STOREY EVACUATION CENTER TO BE CONSTRUCTED IN BRGY. TALISAY, MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the Municipality of San Benito, Siargao Island, Surigao del Norte is one of the nine (9) coastal municipalities in Siargao Island topographically located at the northwestern portion of Siargao and is always prone with storm surges, saltwater intrusion and landslide, making it vulnerable to any climatological changes occurring in the area;

WHEREAS, for longest time, the municipality of San Benito has no evacuation center equipped with facilities where to evacuate our affected residents during the onslaught of typhoons, heavy rains and very bad weather condition that really brought havoc to the lives of the people in coastal and landslide prone areas;

WHEREAS, being classified as 6th class Municipality, construction of this dream project using the LGU own resources is very impossible to realize considering its very limited financial resources, thus financial help from the Office of the Civil Defense (OCD) of the Department of National Defense (DND) is very vital and of paramount importance;
