GINA SUMANDO -MENIL, LCB TO ALOCATE CERTAIN SPACE IN SELECTED GOVERNMENT / PUBLIC BUILDINGS AND INFRASTRUCTURES TO BE USED AS CARENDERIA FOR PREGNANT AND LACTATING MOTHERS IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, pregnant women and lactating mothers need special care and attention especially that their health and nutrition is of vital importance for the development of both mother and the child in this particular and very critical phase;

WHEREAS, a dedicated CARENDERIA for this purpose would serve as a valuable resource to ensure that pregnant and lactating mothers have access to wholesome and affordable meals;

WHEREAS, the aforementioned Carenderia would offer balanced and nutritious meals tailored to the dietary needs of pregnant and lactating women; it would also be a place where mothers can gather, share experiences and receive guidance on proper nutrition during pregnancy and lactation phases;









