“A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE Ma. GINA SUMANDO – MENIL TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO, SURIGAO DEL NORTE WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED HEREIN BY THE DSWD CARAGA REGION XIII DIRECTOR MARI-FLOR A. DOLLAGA-LIBANG IN RELATION TO THE DATA SHARING AGREEMENT (DSA) IMPLEMENTATION OF THE NATIONAL HOUSEHOLD TARGETING SYSTEM FOR POVERTY REDUCTION (NHTS-PR) ALSO KNOWN AS LISTAHANAN IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the DSWD, a National Government Agency tasked to implement the National Household Targeting System for Poverty Reduction (NHTS-PR) otherwise known as “Listahan”, to establish a system for identifying who and where the poor households are, maintain the system that will serve as repository of the data on poor households, update the data every four years, and share the data especially to NGAs — which shall serve as basis in the selection of beneficiaries of social protection programs nationwide;

WHEREAS, the Department of Social Welfare and Development (DSWD) is mandated to assist other national government agencies (NGAs), local government units (LGUs), non-government organizations (NGOs), people's organizations (POs), and members of civil society in the implementation of programs, projects, and services that will alleviate poverty and empower disadvantaged individuals, families and communities to improve their quality of life;

WHEREAS, the Municipal Government of San Benito (LGU-San Benito) is mandated to under the Local Government Code of 1991 to continuously raise the standards of governance through the empowerment of the citizenry; the outcomes from effective partnerships and cooperation shall secure total quality of life of all the citizens; likewise task to implement the social protection programs and services defined in Annex A and be allowed to secure access to Listahanan database maintained by the First Party;

WHEREAS, authorization from this august body to the Municipal Mayor in entering into a Memorandum Of Agreement (MOA) is very vital and of paramount importance, hence the adoption of this resolution;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member William A. Polican duly seconded by SKF President Delcy Rose S. Plandano, be it:


RESOLVED AS IT IS HEREBY RESOLVED to authorize the Municipal Mayor, Honorable Ma. Gina Sumando – Menil to enter into a Memorandum Of Agreement (MOA) and sign in behalf of the Municipal Government of San Benito, Surigao del Norte with the Department of Social Welfare and Development (DSWD) represented herein by the DSWD Caraga Region XIII Director Mari-Flor A. Dollaga-Libang in relation to the Data Sharing Agreement (DSA) Implementation of the National Household Targeting System for Poverty Reduction (NHTS-PR) also known as “Listahanan” in the Municipality of San Benito, Siargao Island, Surigao del Norte;


RESOLVED FINALLY, that copies of this resolution be furnished the Office of DSWD Caraga Region XIII Regional Director, Butuan City and the Office of the Municipal Mayor, San Benito, Surigao del Norte and all other concerned agencies for information and guidance;




