“A RESOLUTION ADOPTING AND AFFIRMING THE PROPOSED ANNUAL INVESTMENT PROGRAM (AIP) FOR FISCAL YEAR 2024 OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE IN THE TOTAL AMOUNT OF ONE BILLION SEVEN HUNDRED FIFTY-NINE MILLION ONE HUNDRED TWENTY-SEVEN THOUSAND AND NINE HUNDRED THIRTY-TWO PESOS (P1,759,127,932.00) WHICH INCLUDE THE AMOUNT OF FOURTEEN MILLION EIGHT HUNDRED FIVE THOUSAND SIXTY PESOS AND FORTY CENTAVOS (P 14, 805, 060.40) FOR PROGRAMS AND PROJECTS UNDER THE 20% LOCAL DEVELOPMENT FUND, EIGHTY-SEVEN MILLION TWO HUNDRED SIXTY-SIX THOUSAND EIGHT HUNDRED SEVENTY-ONE PESOS & NINETY-SEVEN CENTAVOS (P87,266,871.97) INVESTMENT REQUIREMENTS FOR REGULAR OPERATIONS, PROGRAMS AND PROJECTS AND ONE BILLION SIX HUNDRED FIFTY-SEVEN MILLION AND FIFTY-SIX THOUSAND PESOS (P 1,657,056,000.00) FOR PROGRAMS AND PROJECTS PROPOSED FOR EXTERNAL AND OTHER FUNDING “

WHEREAS, submitted for review of this honorable body the Annual Investment Program (AIP) for Fiscal Year 2024 of the Municipality of San Benito, Siargao Island, Surigao del Norte in the amount of **ONE BILLION SEVEN HUNDRED FIFTY-NINE MILLION ONE HUNDRED**

TWENTY-SEVEN THOUSAND AND NINE HUNDRED THIRTY-TWO PESOS (P1,759,127,932.00);

WHEREAS, the total budget amount of AIP for FY 2024 is an accumulated amount to include the budgets of **Fourteen Million Eight Hundred Five Thousand Sixty Pesos And Forty Centavos (P 14, 805, 060.40)** for programs and projects under the 20% Local Development Fund, **Eighty-Seven Million Two Hundred Sixty-Six Thousand Eight Hundred Seventy-One Pesos & Ninety-Seven Centavos (P87,266,871.97)** investment requirements for Regular Operations, Programs and Projects and **One Billion Six Hundred Fifty-Seven Million and Fifty-Six Thousand Pesos (P 1,657,056,000.00)** for programs and projects proposed for External and Other Funding;

WHEREAS, upon scrutiny and study of this august body it appears that said AIP for FY 2024 is within the budgetary limit of this Municipal Government and such programs, projects and activities containing thereat are consistent and in accord with the provisions of R.A. No. 6975 and DILG Memorandum Circular 2011-024 and 2015-128 respectively;






