“A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE Ma. GINA SUMANDO-MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO WITH THE PHILIPPINE COAST GUARD - COAST GUARD DISTRICT NORTH EASTERN MINDANAO (PCG-CGDNEM) HEREIN REPRESENTED BY CG COMMO CHRISTOPHER M. MENIADO IN RELATION TO THE ESTABLISHMENT OF COAST GUARD SUB-STATION IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the island of Siargao is a maritime corridor where sea vessels and sea crafts of any type is regularly plying over this route, thus a need of a certain Government Agency task to handle and is responsible for maritime safety, security, law enforcement, search and rescue, and maritime environmental protection is of vital importance;

WHEREAS, in order to perform all these functions, there is a need to enhance Philippine Coast Guard (PCG) accessibility, as well as its assets, specifically in terms of activation of Coast Guard Sub-Stations and infrastructure projects which is part of its development programs;

WHEREAS, the Municipality of San Benito in Siargao Island has its own share in this maritime corridor and that the Municipality has the potential in the future to be the an alternative port in Siargao, where several types of sea vessels are foreseen to conduct their loading and unloading activities while entering the maritime passageway of Siargao island

WHEREAS, in coordination with appropriate government agencies, the Philippines Coast Guard shall identify, and implement a nationwide development plan for the PCG bases and other infrastructure facilities that include search and rescue, aids to navigation, maritime communications, medical facilities, and personnel barracks and quarters, among others so as to establish strategic presence and accessibility jn the promotion of maritime safety, security and environmental protection;

WHEREAS, the PCG-CDNEM is. conducting maritime operations within the waters of the Municipal Government of San Benito, particularly under the area of responsibility of Coast Guard Station - Siargao;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member William A. Polican. duly seconded by Sangguniang Bayan Member Jayrom P. Caballejos, be it:






