GINA SUMANDO-MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO (LGU-SAN BENITO) WITH RS1 EVENTS MANAGEMENT SERVICES, REPRESENTED HEREIN BY ITS OWNER / PROPRIETOR, MR. REINHARD G. SANTOS IN RELATION TO THE DUTIES AND RESPONSIBILITIES OF BOTH PARTIES DURING THE CONDUCT OF THE 1st SIARGAO INTERNATIONAL HARBOR RUSH EVENT (INTER ISLAND REGATTA) IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, submitted for review and consideration of this august body the draft of the Memorandum Of Agreement (MOA) to be entered into by and between the Municipal Government of San Benito (LGU-San Benito) represented herein by the Municipal Mayor, Hon. Ma. Gina Sumando-Menil, LCB and the RS1 Events Management Services, organizer represented herein by its Owner / Proprietor, Mr. Reinhard G. Santos in relation to the conduct of the 1st Siargao International Harbor Rush Event (Inter Island Regatta) in the Municipality of San Benito, Siargao Island, Surigao del Norte;

WHEREAS, said inter island regatta is scheduled to be conducted this May 23 – 25, 2025 commencing from Manila Hotel at the Manila Bay and culminate the race right at the shores of San Benito in Siargao Island;

WHEREAS, the said MOA contain among others the duties and responsibilities of both parties purposely outlined in connection with the planning, organizing, and execution of the 1st Siargao International Harbor Rush Event which will feature various competitive activities, including but not limited to boat races, water sports exhibitions, and related activities;

WHEREAS, this one of a kind inter island regatta is seen to be a potent catalyst for tourism development in this municipality which will definitely provide additional source of income of the local populace and boost trade and commerce in the northern portion of Siargao Island;

WHEREAS, in cognizance of the beneficial effects of this engagement to the development of the tourism industry of San Benito and the potential livelihood intervention that this event may bring to the people, this august body finds it very compelling and appropriate to authorize the Municipal Mayor to enter into and sign a MOA between RS1 Events Management Services, hence the adoption of this resolution;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Delfin P. Labola duly seconded by Sangguniang Bayan Member Felix B. Sumando, Sr., be it,


