“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY FERDINAND “BONGBONG” R. MARCOS, JR., PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES THROUGH HONORABLE AMENAH F. PANGANDAMAN, SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED EIGHTY MILLION PESOS (₱ 180,000,000.00) TO FUND THE CONSTRUCTION OF 5 KILOMETERS BOARD WALK / FOOT BRIDGE PROJECT IN BARANGAY TALISAY TO PONEAS ISLAND HIDDEN LAKE, BARANGAY MARIBOJOC, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, since time immemorial the residents of Barangay Maribojoc of the Municipality of San Benito, Surigao del Norte are always confronted with never ending hassle in docking their small bancas and motorized boats especially during very low tide, where majority of them are compelled to retain their boats (livelihood vehicles) away from the shoreline and duly exacerbated by their arduous foot walk with almost a kilometer going to their respective dwelling places;

WHEREAS, walking by foot of that distance is such an awful and risky condition for this will always lead to trampling without noticing the sea grasses, sea urchins, star fishes and other marine species found in the area specially for those visitors, guests and those who are not used in this kind of situation who just happen to visit the place that would definitely leave a bad impression on their minds;

WHEREAS, the Poneas Hidden Lake located at Barangay Maribojoc in the northwestern part of Siargao Island is consider to be the major tourist destination of the Municipality of San Benito; connecting this lake from Barangay Talisay passing through the mangrove channel of Barangay Maribojoc would definitely boost tourist arrival in the area that will bring economic and livelihood opportunity to the inhabitants of this area;










WHEREAS, the Municipal Government of San Benito being a 5th class LGU definitely could not finance the construction of this project using only the very limited resources of the municipality, thus a financial intervention from the highest officer of the land, His Excellency President Bongbong Marcos, Jr., is of paramount importance;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Delfin P. Labola duly seconded by Sangguniang Bayan Member Aldrein C. Gimane, be it:

RESOLVED AS IT IS HEREBY RESOLVED to earnestly request His Excellency Ferdinand “Bongbong” R. Marcos, Jr., President of the Republic of the Philippines through Honorable Amenah F. Pangandaman, Secretary of the Department of Budget and Management (DBM) to extend financial assistance in the amount of One Hundred Eighty Million Pesos (P 180,000,000.00) to fund the construction of 5 Kilometers Board Walk / Foot Bridge Project in Barangay Talisay to Poneas Island Hidden Lake, Barangay Maribojoc, San Benito, Siargao Island, Surigao del Norte;
