### **RESOLUTION NO. 004** Series of 2025

**“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY FERDINAND “BONGBONG” R. MARCOS, JR., PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES THROUGH HONORABLE AMENAH F. PANGANDAMAN, SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED TWENTY MILLION PESOS (₱ 120,000,000.00) TO FUND THE CONSTRUCTION OF 3 KILOMETERS FARM-TO-MARKET ROAD / LOCAL ACCESS ROAD PROJECT IN BARANGAY SAN JUAN TO BARANGAY NUEVO CAMPO, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”**

**WHEREAS**, the 3 Kilometers San Juan – Nuevo Campo Road is considered as Farm-to-Market Road and at the same time a Local Access Road going to San Benito Port;

**WHEREAS**, the San Juan – Nuevo Campo Road serves as the main road of the people of Barangays Nuevo Campo and San Juan, San Benito in transporting their farm products from their respective barangays going to the poblacion of the Municipality of San Benito, Siargao Island, Surigao del Norte;

**WHEREAS**, for almost two (2) decades, this road really needs to be concreted for the reason that it is very impassable, muddy and unsafe for the farmers in transporting their farm products to the poblacion of San Benito either by means of barefoot walk and or habal-habal ride

and that they were compelled to use another route passing through the Municipalities of San Isidro and Del Carmen respectively;

**WHEREAS**, due to this prevailing situation the agony of the farmers of these two agricultural barangays are being aggravated and that this led to their economic downgrade due to high cost of transportation and long way travel, thus a need of immediate repair of that road is very vital and of paramount importance;

**WHEREAS**, this particular road is at the same time an access road going to the port of San Benito, that if ever concreted this will definitely bring economic return, allowing more passengers to pass through this road heading to the City of Surigao via Port of San Benito;

**WHEREAS**, the Municipal Government of San Benito, being a 5<sup>th</sup> Class LGU and in cognizance of its very limited resources it could not definitely finance its construction, thus financial help and assistance from the highest officer of the land is very vital and of paramount importance;

**WHEREFORE**, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Felix B. Sumando, Sr duly seconded by Sangguniang Bayan Member William A. Polican, be it,


**RESOLVED AS IT IS HEREBY RESOLVED** earnestly request His Excellency Ferdinand "Bongbong" R. Marcos, Jr., President of the Republic of the Philippines through Honorable Amenah F. Pangandaman, Secretary of the Department of Budget and Management (DBM) to extend financial assistance in the amount of One Hundred Twenty Million Pesos (P 120,000,000.00) to fund the construction of 3 Kilometers Farm-To-Market Road / Local Access Road Project in Barangay San Juan to Barangay Nuevo Campo, San Benito, Siargao Island, Surigao del Norte ;
