**“A RESOLUTION INTERPOSING NO OBJECTION ON THE PREVENTIVE MAINTENANCE – TERTIARY ROADS ALONG JCT. DEL CARMEN – STA. MONICA – SAN ISIDRO (PHASE 2) S0009SG-K0034 + 000 – K0036 + 500 NATIONAL ROAD WITHIN THE VICINITY OF BRGY. TALISAY, SAN BENITO, SURIGAO DEL NORTE, SAN BENITO, SURIGAO DEL NORTE IN THE AMOUNT OF ONE HUNDRED MILLION PESOS (P 100,000,000.00) UNDER THE GENERAL APPROPRIATION ACT (GAA) OF 2025 AND FURTHER ENDORSING BARANGAY RESOLUTION NO. 0016 SERIES OF 2025 OF BARANGAY TALISAY, SAN BENITO, SURIGAO DEL NORTE FOR PROTECTED AREA MANAGEMENT BOARD (PAMB) APPROVAL”**

**WHEREAS**, presented for consideration is the request of the Project Management Team of LGU-San Benito, requesting this august body for the interposition of no objection on the Preventive Maintenance – Tertiary Roads along Jct. Del Carmen – Sta. Monica – San Isidro (Phase 2) S0009SG-K0034 + 000 – K0036 + 500 National Road within the vicinity of Brgy. Talisay, San Benito, Surigao del Norte in the amount of One Hundred Million Pesos (P 100,000,000.00) under the General Appropriation Act (GAA) of 2025 and further requesting for the endorsement of Brgy. Talisay Resolution No. 016 series of 2025 for PAMB approval;
