"A RESOLUTION INTERPOSING NO OBJECTION ON THE CONSTRUCTION OF MULTI-PURPOSE BUILDING (BARANGAY GYMNASIUM) OF BRGY. SAN JUAN, SAN BENITO, SURIGAO DEL NORTE IN THE AMOUNT OF FIVE MILLION PESOS (P 5,000,000.00) UNDER THE GENERAL APPROPRIATION ACT (GAA) OF 2025 AND FURTHER ENDORSING BARANGAY RESOLUTION NO. 004 SERIES OF 2025 OF BARANGAY SAN JUAN, SAN BENITO, SURIGAO DEL NORTE FOR PROTECTED AREA MANAGEMENT BOARD (PAMB) APPROVAL"

WHEREAS, presented for consideration is the request of the Project Management Team of LGU-San Benito, requesting this august body for the interposition of no objection on the Construction of Multi-Purpose Building (Brgy. Gymnasium) of Brgy. San Juan, San Benito, Surigao del Norte in the amount of Five Million Pesos (P 5,000,000.00) under the General Appropriation Act (GAA) of 2025 and further requesting for the endorsement of Brgy. Bongdo Resolution No. 004 series of 2025 for PAMB approval;

WHEREAS, upon careful study of the documents submitted and upon compliance to the documentary requirements, it revealed that the proposed Construction of Multi-Purpose Building worth Five Million Pesos (\$\Pm\$ 5,000,000.00) under the General Appropriation Act (GAA) of 2025 does not cause any violation to the Zoning regulation set forth by the Municipal Government of San Benito and that this facility is beneficial to the well-being of the people of the Municipality of San Benito, Siargao island, Surigao del Norte;
