“A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE Ma. GINA SUMANDO – MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPALITY OF SAN BENITO, SURIGAO DEL NORTE WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED HEREIN BY ITS REGIONAL DIRECTOR IN RELATION TO THE TRANSFER OF FUNDS OF THE SENIOR CITIZENS SOCIAL PENSION TO THE MUNICIPAL GOVERNMENT OF SAN BENITO (LGU-SAN BENITO), SURIGAO DEL NORTE FROM THE DSWD-REGIONAL OFFICE XIII, PROVIDING MECHANISM THERETO IN CONNECTION WITH THE DISTRIBUTION AND LIQUIDATION OF FUNDS”

WHEREAS, the indigent senior citizens of the Municipality of San Benito, Siargao Island, Surigao del Norte has long been receiving their social pension in quarterly basis, wherein personnel from DSWD-Regional Office XIII were sent to personally conduct the distribution of these social pension to the indigent senior citizens of this municipality;

WHEREAS, DSWD Memorandum Circular # 006 series of 2024 or the Enhanced Omnibus Guidelines in the Program Implementation of the Social Pension for Indigent Senior Citizens allows fund transfer to LGUs as one of the payout modalities in the implementation of delivery and distribution of the stipend to the indigent senior citizens;


WHEREAS, the LGU-San Benito for the past years exhibited a good and sound track record in implementing efficient mechanisms in delivering the cash payout to the social pension beneficiaries down to the barangay level;

WHEREFORE, foregoing premises considered and upon the motion of LNMB President Ruella T. Rulete duly seconded by SKF President Aira Mae C. Galano, be it:

RESOLVED AS IT IS HEREBY RESOLVED to authorize the Municipal Mayor, Honorable Ma. Gina Sumando – Menil, LCB to enter into a Memorandum Of Agreement (MOA) and sign in behalf of the Municipality of San Benito, Surigao del Norte with the Department of Social Welfare and Development (DSWD) represented herein by its Regional Director in relation to the implementation of the Transfer of Funds of the Senior Citizens Social Pension to the Municipal Government of San Benito (LGU-San Benito), Surigao del Norte from the DSWD-Regional Office XIII, providing mechanism thereto in connection with the distribution and liquidation of funds;
