RESOLUTION NO. 014 Series of 2022

“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND “BONGBONG” R. MARCOS, JR., PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES TO APPROPRIATE FUNDS IN THE TOTAL AMOUNT OF FORTY-FIVE MILLION PESOS (₱ 45,000,000.00) TO BE USED FOR THE CONSTRUCTION / INSTALLATION OF SOLAR – POWERED STREET LIGHTS OF THE BARANGAY STREETS OF BARANGAYS BONGDO, MARIBOJOC, NUEVO CAMPO AND SAN JUAN ALL OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the people of Barangays Bongdo, Maribojoc, Nuevo Campo and San Juan all of the Municipality of San Benito, Siargao Island, Surigao del Norte since time immemorial are dreaming for a well-equipped lighting facilities along the streets of their respective barangays;

WHEREAS, for several years the streets of these four (4) barangays are always dim and dark during nighttime due to insufficient lighting facilities which are only relying on the electric cooperative's pole electrification found in every street corners;

WHEREAS, the Barangay Officials of these four (4) Barangay Local Government Units (BLGU) are always complaining for being not able to pay their monthly electric bills due to very limited financial resources of their barangays which led to repetitive power disconnection of their street lights;

WHEREAS, the constituencies of San Benito together with the local officials firmly believed that fully equipped lighting facilities in the locality is a major deterrence for juvenile delinquencies and criminalities along nighttime, hence the passage of this resolution;

WHEREAS, being a 6th-Class Municipality, construction / installation of Solar - Powered Street Lights in the four (4) barangays is very impossible to realize using only the very limited resources of this municipality, thus, financial aid from the Office of the good President of the Republic of the Philippines, His Excellency Bongbong Marcos, Jr., is very vital and of paramount importance;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Charlito E. Mendavia duly seconded by Sangguniang Bayan Member Felix B. Sumando, Sr., be it;


RESOLVED AS IT IS HEREBY RESOLVED to earnestly request His Excellency President Ferdinand “Bongbong” R. Marcos, Jr., President of the Republic of the Philippines to appropriate funds in the total amount of Forty-Five Million Pesos (₱ 45,000,000.00) to be used for the construction / installation of Solar – Powered Street Lights of the barangay streets of the following Barangays:

Brgy. Bongdo	₱ 10,000,000.00;
Brgy. Maribojoc	₱ 15,000,000.00;
Brgy. Nuevo Campo	₱ 10,000,000.00;
Brgy. San Juan	₱ 10,000,000.00;


all of the Municipality of San Benito, Siargao Island, Surigao del Norte and subsequently requesting for its inclusion in the 2022 General Appropriation Act (GAA) list of funded projects;

RESOLVED FINALLY, that copies of this resolution be furnished the Office of the President, Malacañang Palace Compound, New Executive Building, J.P. Laurel St., San Miguel, 1005, Manila for information and favorable action;




