ZUBIRI, SENATE PRESIDENT, SENATE OF THE PHILIPPINES (19TH CONGRESS) TO APPROPRIATE FUNDS IN THE TOTAL AMOUNT OF TWO HUNDRED FORTY MILLION PESOS (P 240, 0000,000.00) FOR THE BARANGAY ROAD CONCRETING WITH LINE CANAL PROJECT IN ALL SIX (6) BARANGAYS OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the Municipality of San Benito, Siargao Island, Surigao del Norte is being comprised by six (6) barangays namely: Brgy. Bongdo, Brgy. Maribojoc, Brgy. Nuevo Campo, Brgy. San Juan, Brgy. Sta. Cruz and Brgy. Talisay respectively;

WHEREAS, the existing roads of these barangays are not anymore fit for public use due to its deplorable condition, thus a need of rehabilitating it by way of concreting is the best option to consider;

WHEREAS, concreting of these barangay roads definitely bring economic return to the people of the six barangays of this municipality, for this will provide easy access of bringing their farm and fishery products down to nearby public market;

WHEREAS, these six barangays are identified as tourist destinations of the Municipality of San Benito, improvement in road network is very vital in boosting the tourism industry in this area;

WHEREAS, the Municipality of San Benito, being a 6th- class LGU definitely could not finance construction of such project using only its limited resources, thus financial intervention and help from the good Office of Senate President Juan Miguel F. Zubiri is in dire need and of paramount importance:


