“A RESOLUTION INTERPOSING NON - CONCURRENCE / NON – CONFIRMING THE APPOINTMENT OF MR. SAMUEL E. BAGOT, SR. AS MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICER (MENRO) OF THE MUNICIPALITY OF SAN BENITO, SURIGAO DEL NORTE IN THE GROUND THAT THE APPLICANT DID NOT MEET THE MINIMUM QUALIFICATION STANDARD OF THE POSITION”

WHEREAS, submitted for concurrence and confirmation of this honorable body, the appointment of Mr. Samuel E. Bagot, Sr. as the new Municipal Environment and Natural Resources Officer (MENRO) of the Municipality of San Benito, Surigao del Norte to fill in the vacant slot for the position;

WHEREAS, the submitted documents were received by the Office of the Secretary to the Sangguniang Bayan on August 1, 2022 at 3:30 o'clock in the afternoon and subsequently calendared in the 6th Regular Session for Committee Referral, referring the said documents for concurrence to the Committee on Good Government, Public Ethics and Accountabilities on August 08, 2022 in adherence to the generally accepted Parliamentary Rules of Procedures;

WHEREAS, attach is the Committee Report of the Committee on Good Government, Public Ethics and Accountabilities containing the full length review on the findings and recommendation on the submitted pertinent application documents and such report is made part and parcel of this non – concurrence resolution;

WHEREAS, upon perusal and scrutiny of this body of the submitted documents of the applicant, the application of Mr. Samuel E. Bagot, Sr. as Municipal Environment and Natural Resources Officer (MENRO) does not conform to the requirements set by law, for the reason that the applicant did not met the minimum Qualification Standard (QS) of the position set by Local the Government Code of 1991 (RA 7160) and the Civil Service Commission (CSC) respectively, specifically on Educational Background and 3 – Years of Relevant Experience;

WHEREAS, the findings and recommendations of the Committee on Good Government, Public Ethics and Accountabilities is accordingly adopted by the majority of the Sangguniang Bayan in session assembled;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Aldrein C. Glimane duly seconded by Sangguniang Bayan Member Cindy R. Agati, be it:

RESOLVED AS IT IS HEREBY RESOLVED to interpose Non - Concurrence / Non – Confirming the appointment of Mr. Samuel E. Bagot, Sr. as Municipal Environment and Natural Resources Officer (MENRO) of the Municipality of San Benito, Surigao del Norte in the ground that the applicant did not meet the minimum Qualification Standard of the position;

RESOLVED FINALLY that copies of this resolution be furnished the Office of the Municipal Mayor of San Benito, Surigao del Norte and the Office of the Provincial Director of the Civil Service Commission – Surigao del Norte Field Office, Sison, Surigao del Norte for information and guidance;




