### **RESOLUTION NO. 022** Series of 2022

**“A RESOLUTION EARNESTLY REQUESTING HONORABLE CRISTINA G. FRASCO, SECRETARY OF THE DEPARTMENT OF TOURISM (DOT) TO APPROPRIATE FUNDS IN THE AMOUNT OF THREE HUNDRED MILLION PESOS (₱ 300,000,000.00) TO BE USED IN THE CONSTRUCTION OF 5 – KILOMETER BOARDWALK / FOOT BRIDGE FROM BARANGAY TALISAY, SAN BENITO, SURIGAO DEL NORTE TO PONEAS HIDDEN LAKE OF BARANGAY MARIBOJOC, SAN BENITO, SURIGAO DEL NORTE”**

**WHEREAS**, since time immemorial the residents of Barangay Maribojoc of the Municipality of San Benito, Surigao del Norte and Barangay Talisay are always confronted with never ending hassle in docking their small bancas and motorized boats especially during very low tide, where majority of them are compelled to retain their boats (livelihood vehicles) away from the shoreline and duly exacerbated by their arduous foot walk going to their respective dwelling places;

**WHEREAS**, walking by foot of that distance is such an awful and risky condition for this will always lead to trampling without noticing the sea grasses, sea urchins, star fishes and other marine species found in the area specially for those visitors, guests and those who are not used in this kind of situation who just happen to visit the place that would definitely left a bad impression on their minds;

**WHEREAS**, the Poneas Hidden Lake located at Barangay Maribojoc in the northwestern part of Siargao Island is consider to be the major tourist destination of the Municipality of San Benito; connecting this lake from Barangay Talisay passing through the mangrove channel of Barangay Maribojoc would definitely boost tourist arrival in the area that will bring economic and livelihood opportunity to the inhabitants of this area;

**WHEREAS**, the Municipal Government of San Benito being a 6<sup>th</sup> class LGU definitely could not finance the construction of this project using only the very limited resources of the municipality, thus financial intervention from the Office Honorable Cristina G. Frasco, Secretary of the Department of Tourism (DOT) is very vital and of paramount importance;






