### **RESOLUTION NO. 027** Series of 2022

**“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND “BONGBONG” R. MARCOS, JR. THROUGH HONORABLE AMENAH P. PANGANDAMAN, SECRETARY – DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO APPROPRIATE FUNDS IN THE AMOUNT OF TEN MILLION PESOS (P 10,000,000.00) TO BE USED FOR THE CONSTRUCTION OF MULTI-PURPOSE BUILDING (COVERED COURT) OF BARANGAY SAN JUAN, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”**

**WHEREAS**, the existing Multi-Purpose Building (covered court) of Brgy. San Juan, San Benito, Siargao Island, Surigao del Norte is already dilapidated being made only of woods and it is now currently vacated and condemned for several years due to very fragile structural bearing that could never withstand during occurrences of typhoons, earthquakes and other weather disturbances;

**WHEREAS**, the multi-purpose building (covered court) will serve as the venue for sports activities and any public gatherings and ceremonies in the locality where people congregate in order to join, participate and engage in such affairs that will promote communal and multi-stakeholders' participation;

**WHEREAS**, being a 6<sup>th</sup>-Class LGU, construction of a new and concrete Multi-Purpose Building (covered court) is very impossible to realize using only the very limited resources of this municipality; thus, financial assistance from the Office of Secretary Pangandaman of DBM is very vital and of paramount importance;

**WHEREFORE**, foregoing premises considered and upon the motion of LNMB President Ruella T. Rulete duly seconded by Sangguniang Bayan Member William A. Polican, be it;

**RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request His Excellency President Ferdinand “Bongbong” R. Marcos, Jr. through Honorable Amenah P. Pangandaman, Secretary – Department of Budget and Management (DBM) to appropriate funds in the amount of Ten Million Pesos (₱ 10,000,000.00) to be used for the construction of Multi-Purpose Building (Covered Court) of Barangay San Juan, San Benito, Siargao Island, Surigao del Norte;

**RESOLVED FINALLY**, that copies of this resolution be furnished the Office of DBM Secretary, Hon. Amenah P. Pangandaman, Boncodin Hall, General Solano St., San Miguel, Manila for information and favorable action;

**PASSED AND ADOPTED** this, 19<sup>th</sup> day of September 2022.


