“A RESOLUTION AUTHORIZING THE UTILIZATION OF THREE (3) VACANT ROOMS / SPACES FOR LEASE LOCATED AT THE MUNICIPAL GYMNASIUM BUILDING TO BE USED AS THE TEMPORARY OFFICE SPACE AND SHELTER OF THE PERSONNEL FROM THE BUREAU OF FIRE PROTECTION (BFP) - SAN BENITO MUNICIPAL FIRE STATION FOR A PERIOD OF TWO (YEARS) WITHOUT PAYING MONTHLY RENTAL PAYMENT UNTIL THE CONSTRUCTION OF FIRE STATION IS COMPLETED AND TURNED-OVER ACCORDINGLY”

WHEREAS, the Municipality of San Benito, Siargao Island, Province of Surigao del Norte is one of the two remaining municipalities in the 1st District (Siargao Island) of Surigao del Norte having no Municipal Fire Station established in the area since time immemorial;

WHEREAS, recently the Municipality of San Benito finally awarded the establishment of a Fire Station complete with facilities including fire trucks and assignment of new BFP personnel to man the daily operation of the station were accordingly deployed with;

WHEREAS, while the construction of San Benito Municipal Fire Station is on-going, BFP personnel assigned in the municipality needs office space where to conduct their daily routinary activities is very vital & of paramount importance;

WHEREAS, in cognizance of this necessity, this august body hereby authorize and allow the utilization of three (3) vacant rooms / spaces for lease located at the Municipal Gymnasium

Building to be used as temporary office space and shelter of the personnel from the Bureau of Fire Protection (BFP) - San Benito Municipal Fire Station for a period of two (years) without paying monthly rental payment until the construction of fire station is completed and turned-over

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member William A. Polican duly seconded by Sangguniang Bayan Member Felix B. Sumando, Sr., be it;

RESOLVED AS IT IS HEREBY RESOLVED to authorize authorize and allow the utilization of three (3) vacant rooms / spaces for lease located at the Municipal Gymnasium Building to be used as temporary office space and shelter of the personnel from the Bureau of Fire Protection (BFP) - San Benito Municipal Fire Station for a period of two (years) without paying monthly rental payment until the construction of fire station is completed and turned-over accordingly;
