"A RESOLUTION EARNESTLY REQUESTING HONORABLE IMEE R. MARCOS, SENATOR OF THE REPUBLIC OF THE PHILIPPINES (19TH CONGRESS) TO APPROPRIATE FUNDS IN THE AMOUNT OF FIFTY MILLION PESOS (P 50,000,000.00) TO BE USED FOR THE CONSTRUCTION OF 700 LINEAR METERS SHORE PROTECTION / SEAWALL WITH CONCRETE SHEET PILE OF BARANGAY STA. CRUZ, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE"

WHEREAS, the Municipality of San Benito, Siargao Island, Province of Surigao del Norte is basically a coastal municipality and is geographically situated at the northwestern tip of Siargao Island;

WHEREAS, during northeast monsoon period the shoreline inhabitants of the municipality are always in great danger due to the direct and continuous lashes of big waves especially during the onslaught of typhoons and other weather disturbances, becoming it a perennial problem;

WHEREAS, as observed for several years, several small water crafts (motorized pump boats and non-motorized bancas) have been devastated due to the absence of shoreline protection and flood control facilities, and this circumstances exacerbate the very low economic viability of the people, being majority are dependent on fishing;

WHEREAS, considering that the municipality is a 6th Class Municipality, it is definitely impossible to finance this project using our local funds, thus, financial assistance from the President of the Republic of the Philippines through the Honorable Senator Imee R. Marcos of the Republic of the Philippines (19th Congress) is of paramount importance;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Delfin P. Labola duly seconded by Sangguniang Bayan Member Cindy R. Agati, be it;

RESOLVED AS IT IS HEREBY RESOLVED to earnestly request Honorable Imee R. Marcos, Senator of the Republic of the Philippines (19th Congress) to appropriate funds in the amount of Fifty Million Pesos (P 50,000,000.00) to be used for the construction of 700 Linear Meters Shore Protection / Seawall with Concrete Sheet Pile of Barangay Sta. Cruz, San Benito, Siargao Island, Surigao del Norte;
