## **RESOLUTION NO. 042**

"A RESOLUTION EARNESTLY REQUESTING HONORABLE AQUILINO DL. PIMENTEL III, SENATOR OF THE REPUBLIC OF THE PHILIPPINES (19<sup>TH</sup> CONGRESS) TO APPROPRIATE FUNDS IN THE AMOUNT OF THIRTY MILLION PESOS (₱ 30,000,000,000) TO THE MUNICIPAL GOVERNMENT OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE TO BE USED FOR THE CONSTRUCTION OF SOLAR STREET LIGHTS WITH SECURITY CAMERAS OF BARANGAYS STA. CRUZ AND TALISAY, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE"

**WHEREAS,** the people of San Benito, Siargao Island, Surigao del Norte since time immemorial is dreaming for a well-equipped lighting facilities along the streets of the poblacion barangays of the municipality;

**WHEREAS**, for several years the streets of San Benito are always dim and dark during nighttime due to the insufficient lighting facilities which are only relying on the electric cooperative's posts found in every street corners;

**WHEREAS**, the constituencies of San Benito together with the local officials firmly believed that fully equipped lighting facilities with security cameras in the locality is a major deterrence for juvenile delinquencies and criminalities along nighttime, hence the passage of this resolution;

**WHEREAS,** considering that the municipality is a 6<sup>th</sup> Class Municipality, it is definitely impossible to finance this project using our local funds, thus, financial assistance from the

Senate of the Philippines through the Honorable Senator Aquilino DL. Pimentel of the Republic of the Philippines (19th Congress) is of paramount importance;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Charlito E. Mendavia duly seconded by Sangguniang Bayan Member Puyat P. Sumando, be it;

RESOLVED AS IT IS HEREBY RESOLVED to earnestly request Honorable Aquilino DL. Pimentel III, Senator of the Republic of the Philippines (19th Congress) to appropriate funds in the amount of Thirty Million Pesos (P 30,000,000.00) to the Municipal Government of San Benito, Siargao Island, Surigao del Norte to be used for the Construction of Solar Street Lights with Security Cameras of Barangays Sta. Cruz and Talisay, San Benito, Siargao Island, Surigao del Norte:
