GINA SUMANDO – MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO, SURIGAO DEL NORTE WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGION XIII IN RELATION TO THE PREPOSITIONING OF RELIEF GOODS (FOOD & NON-FOOD ITEMS) IN THE MUNICIPALITY OF SAN BENITO, SURIGAO DEL NORTE”

WHEREAS, the Municipal Government of San Benito, being a Local Government Unit is mandated to secure its readily available relief goods either food or non – food items in times of disasters and calamities;

WHEREAS, the prepositioning of relief goods is purposely design to provide immediate relief services and assistance for the victims during and in the aftermath of disaster and their return to productive livelihood following the said event;

WHEREAS, the LGU-San Benito is fortunate to be one of the recipient municipalities in Caraga Region to avail the Prespositioning of Relief Goods from the Department of Social Welfare and Development (DSWD) – Region XIII, wherein such goods are to be kept and stored at the designated Relief Warehouse Facility provided by the recipient LGU;
