RESOLUTION NO. 056 Series of 2022

“A RESOLUTION EARNESTLY REQUESTING THE OFFICE OF THE CIVIL DEFENSE OF THE DEPARTMENT OF NATIONAL DEFENSE THROUGH HONORABLE UNDERSECRETARY RAYMUNDO B. FERRER, ADMINISTRATOR & EXECUTIVE DIRECTOR TO ALLOCATE FUNDS AND EXTEND FINANCIAL ASSISTANCE TO THE LOCAL GOVERNMENT UNIT OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE IN THE AMOUNT OF ONE HUNDRED FIFTY MILLION PESOS (P 150,000,000.00) THAT WILL BE USED FOR THE REPAIR AND REHABILITATION OF 700 LINEAR METERS SHORE PROTECTION / SEAWALL OF BARANGAY STA, CRUZ, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE SEVERELY DEVASTATED BY SUPER TYPHOON ODETTE USING THE NATIONAL DRRM FUND”

WHEREAS, on December 16, 2021 at around 11:00 o'clock in the morning until 5:00 o'clock in the afternoon, the whole island of Siargao including the whole municipality of San Benito was hit by Super Typhoon “Odette” with an international name “Rai” at its maximum gustiness and sustained wind of 295 kph, classifying it as Super Typhoon category and hoisting the whole province of Surigao del Norte with Typhoon Signal Warning # 5;

WHEREAS, the onslaught of Super Typhoon Odette brought severe damages to the people of this municipality based on the result of the Rapid Damage Needs Assessment (RDNA) conducted by the composite team of MDRRMO, MSWDO, MEO and MAO, which revealed that 100% of the total population were considered Internally Displaced Persons (IDPs) and that all of

the six barangays mean of livelihood (fishing & farming) including shelters and infrastructure projects owned by the government and private individuals were greatly devastated and severely damaged;

WHEREAS, the existing shore protection / seawall of Brgy. Sta. Cruz was not spared from the wrath of this super typhoon, thus brought severe destruction of said government facility, making it not any more fit to serve its purpose of protecting lives and properties among our marginalized fishermen;

WHEREAS, considering that the municipality is a 6th Class Municipality, it is definitely impossible to finance this rehabilitation project using our local funds, thus, financial assistance from the Office of the Civil Defense of the Department of National Defense through Honorable Undersecretary Raymundo B. Ferrer, Administrator & Executive Director is of paramount importance;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Felix B. Sumando, Sr. duly seconded by LNMB President Ruella T. Rulete, be it;

RESOLVED AS IT IS HEREBY RESOLVED to earnestly request the Office of the Civil Defense of the Department of National Defense through Honorable Undersecretary Raymundo B. Ferrer, Administrator & Executive Director to allocate funds and extend financial assistance to the Local Government Unit of San Benito, Siargao Island, Surigao del Norte in the amount of One Hundred Fifty Million Pesos (₱ 150,000,000.00) that will be used for the Repair and Rehabilitation of 700 Linear Meters Shore Protection / Seawall of Barangay Sta. Cruz, San Benito, Siargao Island, Surigao del Norte severely devastated by Super Typhoon Odette using the National DRRM Fund;

RESOLVED FINALLY, that copies of this resolution be furnished the Office of Usec Raymundo B. Ferrer, Administrator & Executive Director, Office of the Civil Defense (OCD), Camp General Emilio Aguinaldo, Quezon City, Philippines for information and favorable action;






